




Figure 1. Typical Forward Voltage (Per Leg)

Figure 3. Current Derating, Case (Per Leg)






Figure 4. Current Derating, Ambient (Per Leg)




Figure 11. Typical Forward Voltage (Per Leg)

Figure 13. Current Derating, Case (Per Leg)




Figure 14. Current Derating, Ambient (Per Leg)

Figure 15. Power Dissipation (Per Leg)




Figure 16. Thermal Response





Figure 17. Typical Capacitance (Per Leg)
